PHOTOGRAPHERS AND VIDEO OPERATORS MUST SHOW CERTIFICATE OF INSURANCE

1- RULES FOR PRESS ACCREDITATION

Journalists, photojournalists, cameramen, including Free Lance, and radio operators must show an original copy of the accreditation request formulated by a newspaper or telematic organization registered with the court of territorial jurisdiction. Each applicant for press accreditation must show the request for accreditation on the headed paper of the entity they represent, or document that they belong to them. Acceptance of the accreditation request is subject to the approval of the Press Office of the organizer of the event. Each request will be verified so that the real conditions exist for the issue of accreditation and, if necessary, also subject to the supervision of the competent National Sports Federation or higher. For organizational and security reasons, each newspaper will be able to credit a maximum number of nr. 2 journalists and nr. 2 photographers, agencies and / or photographic or video studios a maximum of nr. 4 employees. Any other request will not be accepted except in cases deemed suitable by the Press Office.

ATTENTION: The mere sending of the accreditation request does not in any case represent acceptance of the same by the Press Office.

2- DECLARATION OF RESPONSIBILITY

The undersigned declares to be aware of the dangers that may exist in the context of the car event and to assist in their development along the race course. He also declares to have the experience and professional preparation to safely assist in the performance of them and to undertake every precaution necessary to avoid physical and material damage to himself and to others: to respect the safety orders given by the Race Officials and by the Police; to assume any and all liability for damage that it may suffer, due to its own imprudence or inexperience; to release the Organizing Committee, the Clerk of the Course and any other person, Institution or Association from any and all civil and criminal liability as far as the above extended. The undersigned also undertakes to observe any provisions relating to the use and validity of the pass that may be communicated by the Press Office. Press accreditation is issued exclusively to people over 18 years of age.

The pass delivered by the Press Office is strictly personal and its transfer to third parties is strictly forbidden. Any abuse will result in immediate withdrawal and will be reported to the judicial authorities and the competent National Sports Federation.
