



## INSTRUCTIONS TO ATTEND THE EVENT COVID-19 EMERGENCY

## This document is an integral part of the Supplementary Regulations, failure to comply with the following health rules will lead to sanctions by the Stewards.

For anything not expressly provided for in this document, please refer to the General Protocol for the contrast and containment of the spread of the COVID-19 virus in Motorsport reported above and to the general rules contained therein. These measures will be updated according to medical-scientific developments and ministerial guidelines. Below are all the measures to be taken at each stage of the races.

## **DEFINITIONS:**

- Sports Operator: athlete or support staff present on the sports site on the occasion of the event.
- Protected area: each work area dedicated to the development of the event and in particular:
  - 1) Service Park
  - 2) Headquarters of the event
- 1. Areas used for Amministrative/Technical Scrutineering

- Green Pass "Strengthened": Covid-19 green certification issued following vaccination or recovery, does not include green passes issued as a result of rapid or molecular swabs. In case of exemption, send the appropriate medical certification to the organizer before the closing of registrations.

Competitors with a foreign license will find all the forms on the site www.italianbaja.com that must be sent to the organizer duly completed and with all the documentation required to the email service@italianbaja.com. By the closing date of the registrations, each competitor must send the organizer the complete list of their staff, indicating the name of the contact person and the other sports operators.	1	Entry for the race	Competitors with a foreign license will find all the forms on the <u>site</u> <u>www.italianbaja.com</u> that must be sent to the organizer duly completed and with all the documentation required to the email <b>service@italianbaja.com</b> . By the closing date of the registrations, each competitor must send the organizer the complete list of their staff, indicating the name of the contact person and the other sports operators. Each car participating in a race will have a maximum of passes (bracelets) as shown below: - Car registered by a Competitor P.G.: nr. 8 sports operators





2	Organizer Communication	The organizer will publish in the digital notice board / Sportity all communications concerning the event and / or the applications of the most recent provisions of the health authorities to be observed throughout the event. Any transgressions to these communications will be sanctioned by the Stewards.
4	Road Book Delivery	The conductor, equipped with a mask and respecting the safety distances, will pick up the Road Book before the Start of the Race in the place indicated by the Organizer.
5	Accreditation Center	There must be a time slot in which to present themselves and the organizer must prepare a control for access one at a time of the conductors or referents, the times will be published in the digital notice board / Sportity. The participant's contact person will collect the material (race numbers, passes) for the crew and their staff. In this phase, the contact person will verify the validity and authenticity of the Green Passes in electronic / paper mode of all the participants in the event (crew, staff, companions); it will also deliver the self-certification relating to the possession of the original driving license. Those who have already contracted the infection will need to be able to prove that they have recovered from the infection itself. This documentation must also be delivered to the Organizer. In case of missing, incomplete and/or incorrect documentation entry to the Protected Areas will be allowed. Persons without personal protection systems will not be allowed to enter the Protected Areas.
6	Secretary (Protected Area)	Access to the secretary is allowed only with a special pass / bracelet issued to the Accreditation Center. The use of personal protective equipment is mandatory. For all competitors who will have to carry out the sports checks there will be a time slot in which to present themselves and the organizer will have to prepare a control for access one at a time of the conductors, the times will be published in the digital notice board / sportity
7	Administrative Checks	<ul> <li>Participants with Italian license: Those who have registered by pre-registering online on the ACI Sport website and will have sent all the required documentation to the organizer before the closing of the registrations will have already carried out the administrative checks.</li> <li>Participants with foreign license: They must send all the required documentation to the organizer before the closing of the registrations and present themselves at the Secretary with the originals for administrative checks. The list of verified is published on the digital race book / Sportity.</li> <li>In case of missing, incomplete and / or incorrect documentation, the crew will not be verified and will not be able to access the Protected Areas.</li> </ul>





8	Technical scrutineering <b>(Protected Area)</b>	Competitors must present themselves at the technical scrutineering at the time established by the organizer (all the documentation duly completed and signed must be sent when registering for the <b>email service@italianbaja.com</b> ). In case of missing, incomplete and /or incorrect documentation, the car will be non-compliant. Any punching or the issuance of new technical passports will be carried out, under the respective structures, as per current legislation in compliance with current health regulations.
9	Service Park (Protected Area)	It will take place behind closed doors with limited access only to sports operators, media, staff equipped with passes and personal protective equipment. Access control personnel can request verification of the Green Pass at any time. <b>Any transgressions will be sanctioned by the Sports Commissioners</b>
10	Parc Fermè / regrouping	The movement of the drivers and the collection of the cars in the parc fermè / regrouping must be carried out on the recommendation of the Officials. Each participant after parking the car must follow the instructions of the Officials in order to quickly leave the area while maintaining the necessary interpersonal distances with the other drivers. The pilots, when they take off the helmet, have the obligation to wear the mask immediately.
11	Start / Prize Giving	It is allowed to enter the starting area only to sports operators, media, staff with passes.
