**PHOTOGRAPHERS AND VIDEO OPERATORS MUST SHOW AN INSURANCE CERTIFICATE**

**1- PRESS ACCREDITATION RULES**  
Journalists, photojournalists, videographers, including freelancers, and radio operators must show an original copy of the accreditation request made by a newspaper or online publication registered with the competent territorial court. Each applicant for press accreditation must show the accreditation request on headed paper of the entity they represent, or provide proof of belonging to them. Acceptance of the accreditation request is subject to approval by the Press Office of the event organizer. Each request will be verified to ensure that the actual conditions for issuing the accreditation exist and, if necessary, also subjected to the supervision of the competent National Sports Federation or higher body. For organizational and security reasons, each publication may accredit a maximum of 1 journalist and 2 photographers, agencies and/or photographic or video studios a maximum of 3 employees. Any other request cannot be accepted except in cases deemed suitable by the Press Office. ATTENTION: Simply sending the accreditation request does not in any case represent acceptance of the same by the Press Office.

**2- DISCLAIMER**  
The undersigned declares to be aware of the dangers that may exist in the context of the automotive event and in witnessing their progress along the race route. He also declares to have the experience and professional training to safely witness their progress and to commit to all necessary precautions to avoid physical and material damage to himself and others: to respect the safety orders given by the Race Officials and the Police; to assume any and all responsibility for damages that he may suffer, due to his own imprudence or inexperience; to relieve the Organizing Committee, the Race Director and any other person, Institution or Association from any and all civil and criminal liability for the above. The undersigned also undertakes to observe any provisions relating to the use and validity of the pass that may be communicated by the Press Office. Press accreditation is issued exclusively to those over 18 years of age. The pass issued by the Press Room is strictly personal and its transfer to third parties is strictly prohibited. Any abuse will result in immediate withdrawal and will be reported to the judicial authorities and the competent National Sports Federation.
